The effectiveness of these principles is attested by Metallurgica Marcora' consolidation of its market position and income capacity in recent years, thanks to the attention paid to strategic objectives that have long been considered essential, including the following:

- maintenance of production flexibility, which has always been a fundamental characteristic of the company;

All employees are required to report any conduct or activities that they believe to be unlawful, abusive, and/or inconsistent with the applicable legislation, with the procedures and regulations adopted by the Company, and/or with the provisions of the Code of Ethics. In order to implement an appropriate escalation policy, an internal committee in charge of collecting and evaluating these reports has been established.

This company policy has been created to assure the Company plays a constructive role in the global effort against climate change.

With regard to the current scenarios and future challenges, Metallurgica Marcora considers the containment of its environmental impacts, both in normal working conditions and in emergency conditions, as a primary objective.

The company is actively engaged in the constant adjustment of its production site, aware that its conduct can contribute to a sustainable growth with respect to the natural environment.

The monitoring of environmental aspects of reference, with particular attention to the emissions into the air and water, to the protection of the soil and subsoil, to the maximizing of the recovery, to the effective and sustainable use of raw materials, ensures compliance and the improving environmental performance.
